The **estimated one-year cost** (one-year's tuition + one-year's living expenses) for each graduate program is listed below. For Professional MBA only: You should assume that tuition will rise about 5% for each year of study.

Please remember that student visa holders will not be authorized to work in the U.S. except under special circumstances. You should not plan on employment to provide for your support while you are a student at Saint Mary's College.

When you request your visa from the U.S. consular officials, you will be required to prove that you have sufficient funds to study at Saint Mary's College of California. We suggest, therefore, that you make copies of this form and the related documents for that purpose.
